## Expansion of ERFA and reinforcement of the ERFA Board, strengthening the voice of independent rail operators in Europe, as Vice-President & Commissioner Siim Kallas and TRAN Chair Brian Simpson pledge their strong on-going support to the sector

At its 13th General Assembly Meeting held on 1st April 2014 the European Rail Freight Association welcomed three new members into the association, the Bulgarian Railway Company (BRC), the Italian rail freight association FerCargo and for the first time in ERFA's history a passenger operator, Westbahn from Austria.

ERFA furthermore welcomed three existing members, **NEE**, **MT Group** and **Rail Cargo Europe** onto the Board of Directors. This general assembly was also a unique opportunity to introduce a new member of staff to our community: Julia Lamb, who was unanimously selected by our board. Julia is the former Head of Cabinet for the Chairman of the European Parliament Transport Committee and will succeed as Secretary General to Pierre Tonon on 1<sup>st</sup> July.

The Association's expansion and the reinforcement of the Board is timely. It comes at a moment when the sector is at a crossroads. As very clearly outlined by President François Coart, in a special seminar event held following the General Assembly, "*the clock is ticking for rail freight*." In the presence of rail stakeholders from across Europe, François Coart stressed the need for firm action in the direction of market opening. "*At the moment this has effectively ground to a halt, while we await the start of Council deliberations on the market pillar and wait to see developments following the European Parliament elections in May.*"

ERFA also took the opportunity to reiterate its strong support for the promising developments on the technical pillar of the 4th railway package, while underlining the critical importance of getting the governance part of the package back on track. ERFA continues to stress the importance of a real separation between infrastructure manager and historic operator.



This point was also strongly made by the Vice President of the European Commission Siim Kallas and by his Director of mobility networks Olivier Onidi. The Commissioner made it clear he would not accept any step backwards from what has already been achieved in the Recast of the First Railway Package, firing a clear warning shot to the Member States ahead of any deliberations in Council.

Brian Simpson, Chairman of the European Parliament's Transport Committee, reiterated his long- standing support for delivering a fair and non-discriminatory level playing field for all rail operators on the market. He pledged his continued support to the rail freight sector in his new capacity as TEN-T coordinator for Motorways of the Seas, where one of his priorities will be to develop and improve rail connections with EU ports.
